Wetland Delineation / Waters of the US / Interim Regional Supplement Wetland Classroom and Field Training

This course covers how to identify and delineate wetlands using the 1987 Wetland Delineation manual (and subsequent clarification memoranda), Waters of the United States based on the SWANCC and Rapanos Supreme Court decisions, and the Interim Regional Supplement methodologies. This course also provides 2.6 credit hours of the 12 necessary to become a Professional Wetland Scientist, satisfies the training requirements of most state Departments of Transportation, and satisfies the Corps training requirements to become a Certified Wetland Delineator *upon implementation*.
